ENTRY FEE ----- \$36.00 (per 100 targets)

PAYOUT: Champion; Class (AA, A, B, C, D); Category (Sub Jr, Jr, Lady, Sub Vet, Vet, Sr Vet)

CLASSIFICATION: AA = 97% and Over; A = 94% to UNDER 97%; B = 91% to UNDER 94%; C = 88% to UNDER 91%; D = UNDER 88%

EVENT 2 - DOUBLES (50 PAIRS = 100 TARGETS)

ENTRY FEE ----- \$36.00 (per 100 targets)

PAYOUT: Champion; Class (A, B, C, D)

Classification: A = 90% AND OVER; B = 85% AND UNDER 90%; C = 85% AND UNDER 90%; D = UNDER 78%

EVENT 3 – DOUBLES (50 PAIRS = 100 TARGETS)

ENTRY FEE ----- \$36.00 (per 100 targets)

PAYOUT: Champion; Class (A, B, C, D)

Classification: A = 90% AND OVER; B = 85% AND UNDER 90%; C = 85% AND UNDER 90%; D = UNDER 78%

EVENT 4 – HIGH OVER ALL (HOA) COMBINED SCORES OF EVENTS 1, 2 and 3

ENTRY FEE ----- \$0.00 (NO entry fee)

PAYOUT: Champion

All shooters must be a member of the ATA/AIM and ASTF and must show proof of membership, or you may join at the shoot. Eye and Ear protection is mandatory. No refunds allowed. In the event of ties, winner determined by reverse long run, start at the 100th target, count backwards until the first missed target. Practice is \$7.00 per round of 25 targets. All money paid per 100 targets. Cash, Check or Credit Card accepted, there will be a \$3.00 upcharge with Credit Cards to cover the transaction fee. Bella Vista Sportsmen's Club (BVSC) Shoot Management reserves the right to change, amend, alter, add, delete or modify this program or any of these terms/conditions without prior notice for the betterment of the shoot.
